Fire Chief's report

Fire Chief Patrick Moore provided an overview of the Fire Chief and operations memorandum that was provided in the Board packet today and attached to the official Governing Board meeting minutes. The following is a summary of the report given:

Work continues Station #2 punch list items.

Laughlin Bullhead Air show is scheduled for Saturday April 1, 2023

Annual audit report attached for Board review.

Pending agreement with the City of BHC, old bays at the Station #3 site will be used to house mass casualty trailer.

Anticipate delivery of the boat, procured through the State Lake Improvement Fund (SLIF) late Fall 2023.

Handheld/Mobile Radios through Mohave County ARPA funding has been awarded in the amount of \$810,000. The funding will replace all the handheld and mobile radios in our fleet.

Grants applied for include SAFER- for 12 firefighters.

AFG for radio upgrade for entire River Valley

Training last month included Valley wide extrication training and other EMS and Wildland training.

Staff will score the Request for Proposal (RFP) to secure Auditing services beginning FY 23-24.

Potential remodel and or repair to a bathroom water leak at Station #5

We continue to monitor bills that will impact the Fire District.

Staff will be meeting with members of the Joint Technical Education Department (JTED) a program that will provide entry level firefighting education at a high school level. Hazardous waste day is April 22, 2023.

Operations Report – Assistant Chief, Justin Flummer

The Ram 2500 Battalion 7 is in its final completion.

Update on the WHP Training Tower, we anticipate the floors to be completed on Monday. Total call volume for February was 858 calls for service, 735 of those calls were EMS. 5 were structure fires and the remainder were good intent cancelled calls.

Chief Moore gave the Logistic report.

Work continues at the Laughlin Ranch Station #7 site.

Chief Moore gave the Fire Marshal report, Barbie is instructing a fire investigation class this week. The Kids expo was well attended and this week the air show the engine 38 will be on display.

Chief Moore stated the annual audit report is complete and has been distributed to the Board for review. We will schedule a special board meeting next month for a presentation of the FY 21-22 Audit by Saunders Company Ltd.

Budget Update.

Chief Moore stated we are still early in the budget process, waiting on costs such as health care costs and workers comp. Work continues revenue and capital items expenses. The first budget workshop is scheduled for May 2, 2023.
