Fire Chief's report

Fire Chief Patrick Moore provided an overview of the Fire Chief and operations memorandum that was provided in the Board packet today and attached to the official Governing Board meeting minutes.

Two employees have been out with COVID.

The Joint Powers of Authority (JPA) study continues. A meeting is scheduled today to discuss staffing standardization.

Legislative changes to the Certificate of Necessity (CON) process regarding standardizing response times will begin in January. River Valley CON's are attached.

Work continues on the Laughlin Ranch Station #7.

Arizona Fire District Association winter conference will be held in January.

Chief Moore advised the Board he has been appointed to the SECURIS Board, this appointment is a 3 year term.

We were declined the staffing SAFER grant as well as the assistance to Firefighters (AFG) Grant.

Staff is working with the auditors on a date for presentation of the FY 22-23 Audit.

We have received the first Type II ambulance, the second is currently on the assembly line. Chief Moore gave an update on the Anna Circle Fire which is under investigation. This was a very emotional and tragic event for everyone involved. Opportunities for counseling and mental wellness will be provided to all members of our department and the agencies that assisted. The focus of our community should be on lifting the spirits of the families, first responders and all others impacted by this tragic incident.

The Assistant Chiefs reports were given within the Fire Chief Report today.
