### Firefighters' Community Report-PFFA Local 3647

Captain Ryan Granath gave an update on fundraising from the Laughlin River Run and BHC River Run and expressed gratitude to PFFA for donations that help Local Veterans.

### Fire Chief's report

Fire Chief Patrick Moore provided an overview of the Fire Chief and operations memorandum that was provided in the Board packet today and attached to the official Governing Board meeting minutes. The following is a summary of the report given:

COVID reimbursement efforts have begun, BCFD does not anticipate applying for reimbursement due to an award for radio replacement has already been awarded.

Concrete work has been completed on the training tower at station #2.

Painting on the warehouse at station #2 and a door project on the mechanics shop should be completed in late June.

An agreement with the City of BHC regarding station #3 storage bays is still pending, we will use the bays to store equipment and trailers.

Firefighters and EMS application period open for four positions.

Legislation update given.

Mohave County Fire Officer Association is exploring the possibility of regional fire authority. The first meeting was held last week to identify the process and need of a study. Laughlin Ranch construction will slow down during summer due to long lead times of the metal building and associated engineering. Work will continue and we anticipate completion early 2024.

Radios awarded through Mohave County for replacement of all handheld and mobile radio in our fleet.

EMS Week luncheon at Anderson Field house this Wednesday.

### Operations Report - Assistant Chief, Justin Flummer

The Battalion 7 vehicle currently has a recall and once addressed it will go into service.

Type II Ambulance and Polaris UTV have been ordered.

The total call volume for April was 947 calls.

### Logistics Report - Assistant Chief, Scott Neal

Station #2 drainage area on the north end will be refurbished in early June.

Station #7 underground work and median cut is near completion.

Station #5-bathroom tilework remodel is near completion.

Station #6 AC repairs under warranty.

Through a community partnership we were able to secure an AED program that allows us to place 30 AED's in BHC Police Patrol vehicles and boats along with training. Wildland refresher training along with platform training.

### Fiscal Year 2023/24 Preliminary Budget

Chief Moore stated the budget presented retains the current tax rate 3.20 we have been working on the budget since January and had two budget workshops.

Board member Jacobs made a motion to approve the preliminary Budget as presented, Board Member Cummings seconded the motion, all were in favor and the motion carried.

### Borrowing Request with Wells Fargo

Chief Moore stated a resolution is required by Wells Fargo for borrowing request for the use of warrants through Mohave County. We did not need to use the warrant last fiscal year and don't anticipate the need this year. This is simply a precautionary step in the event of a catastrophic need for funding.

Board Member Jacobs made a motion to approve resolution 2023-01, borrowing request through Wells Fargo Bank for a line of credit at 8.00% Prime.

Board Member Moore seconded the motion, all were in favor and the motion carried.

Board member Cummings made a motion to schedule the May 30, 2023, special meeting at 10:00 a.m. Board Member Jacobs seconded the motion. All were in favor and the motion carried.
