Progress photos were shared showing the work being completed behind Station #2 (the training tower, flashover chamber, warehouses, etc.) and an update given for what is planned for the drainage from the back side of the property.

Finished Firefighter testing, testing this week for civilian EMS candidates, Captain testing complete and the position was filled.

Legislation update given.

Mohave County Fire Officers Association will be gauging interest in a JPA, sending out letters to area agencies.

Station #7 progress still slowed due to engineering for the bays and delay to electric panel. Wildland team on assignment now, expecting a busy summer.

Staff working with I.T. Security company to ensure our system is secure.

DHS is currently working with agencies to review and make changes to current DHS rules, there is some concern in regard to the response time matrix for IFT transports.
