Temporary Consumer Fireworks Retail Sales (CFRS) Facilities

Minimum Separation Distances

** Where stands are separated from each other by less than 20 feet, the aggregate area of such stands shall not exceed 800 square feet.

Other Requirements

- * The area located within 30 feet of a CFRS facility shall be kept free of accumulated dry grass, dry brush, and combustible debris.
- * Portable generators and their fuels shall be located not less than 20 feet from the CFRS facility. Fuel capacity must not exceed 2 gallons.
- * Cooking equipment of any type shall not be permitted within 20 feet of the CFRS facility.
- * Open flame cooking equipment of any type shall not be allowed within 50 feet of the CFRS facility.
- * At least one fire extinguisher with the minimum rating of 4A80BC shall be required in the sales area. Additional extinguishers may be required depending upon the size of the sales area.
- * Smoking shall not be permitted within 50 feet of the CFRS area.
- * Signs that read “Fireworks – No Smoking” shall be conspicuously posted throughout the CFRS area. The letters shall be a minimum of 2 inches in height and shall contrast with their background.
- * CFRS facilities cannot be closer than 50 feet to:
 1. Retail propane – dispensing station dispensers
 2. Above ground storage tanks for flammable or combustible liquids, flammable gas, or flammable liquefied gas
 3. Compressed natural gas dispensing station dispensers
- * Fireworks shall not be ignited, discharged, or otherwise used within 300 feet of a CFRS facility.
- * Any loose pyrotechnic composition shall be removed immediately.
- * All initial inspections of CFRS facilities shall be conducted a minimum of one day prior to the opening of the site. There shall be no sales without an initial inspection by Bullhead City Fire Department Fire Inspector.
- * Fireworks shall not be sold or dispensed by any person under the age of 16 years. An adult shall be present during all hours of operation.
- * Fireworks shall not be sold or dispensed to any person under the age of 16 years.
