



**Notice of Request for Proposal

Self-Contained Breathing Apparatus (SCBA)**

**Overview:**

The purpose of this RFP is to select one (1) qualified Proponent, with experience in supplying and supporting of MSA G1 SCBAs and associated equipment for the Bullhead City Fire Department as outlined in this RFP document.

No substitutions of Make and Model will be accepted.

It is anticipated that this RFP will result in the purchase of approximately 100% of the current inventory of MSA SCBA to replace specifically the G1 model with an ongoing supply, support and maintenance.

**Request:**

The Bullhead City Fire District is now seeking professional assistance in purchasing a complete set of SCBAs for our Department. The selected vendor shall be qualified to evaluate the Fire District's current needs relating to SCBA specifications and NFPA standards. The proposal shall include:

- Itemized list of parts, equipment and associated/required software.
- Description of the parts, equipment and associated/required software.
- Price per unit and price in total if purchasing more than one unit.
- Warranty information and costs for extended warranty-10 years.
- Shipping and/or handling pricing.
- Sales tax pricing at 7.85% .
- All other costs associated with equipment.
- Estimated delivery date for shipping and arrival of product after potential order.
- Contact information of personnel assigned to this potential order.
- Training & Fit Testing for all BCFD operational personnel (80).
- Technician certification training (6).
- A bid guarantee will not be required for this RFP.
